

### Monongahela Farmers' Market, Monongahela, Pennsylvania Market Operations FARMERS Application/Contract Summer 2025 Season

**Location, Hours and Season:** The Monongahela Farmers' Market will be held, rain or shine, each Friday afternoon from 3:00pm to 6:00pm, running approximately 13 weeks beginning June 13<sup>th</sup> and continuing through September 5<sup>th</sup>. Depending on demand, and customer attendance we may be continuing Market Fridays through September, but we will not be having other vendors, food trucks nor music after September 5<sup>th</sup>. It will be open to only our Farm Vendors and some Food Trucks, and only on 7<sup>th</sup> Street. Our Farmer Vendors will be located on 7<sup>th</sup> Street, which is the side street beside Chess Park.

**Fees and Spaces for Farmers:** The available space will be \$10 a foot per season. Please note, you must be able to park your vehicle and unload it within the confines of your stall. Spaces are limited and there is no guarantee that everyone will receive the number of spaces requested in their application. Spaces will be awarded on a first come/first served basis. If you plan to keep your vehicle at your spot, please know that you must pay for the space the vehicle occupies.

**Participation:** Vendors are expected to participate in at least 10 of the 12 Market days. You are required to give advance notice of the days when they intend not to come in order to permit the Market to better accommodate their absence. Advance notice is no later than 10 am on Thursday. *If you miss 2 Fridays with no notice, you will forfeit your space and will receive no refund.* 

PLEASE NOTE: THERE WILL BE NO MARKET ON FRIDAY JULY 4<sup>TH</sup>. Enjoy your holiday.

**Choice of Farmers:** Farmers will be selected to provide shoppers with an appealing variety of high quality, locally grown or produced agricultural products and foods. However the choice of specific vendors will be made at the discretion of the Market Committee. The Committee may add new vendors at any time during the season.

**Inclement Weather:** The Market Committee will determine if the market will open or close early due to inclement weather. We are a rain, shine or wind event. If there is lightning in the area, the market will close. You are required to pack up and vacate the premises immediately. Failure to do so will void your contract.

**Operating Agency:** The Market is operated by the Monongahela Farmers' Market Committee. Monongahela Area Revitalization Corp (MARC) is the designated Market Coordinator. Most Market activities are performed by volunteers and MARC may delegate much of their powers and duties to those Market volunteers as they deem advisable.
